**RULES**

WAM fishing trips should be FUN! To make these events more enjoyable for everyone, please observe the following guidelines:

1. All WAM trips are limited to current female members on a first come first serve basis. If space permits non members are also welcome. The number of openings for each trip is determined by the Trip Director based on accommodations available.
2. For the comfort and convenience of all participants, no children under 18 years of age or pets of any kind will be permitted on WAM fishing trips
3. All registration fees must be paid in advance. Fees are non-negotiable unless a replacement can be found.
4. Excessive use of alcoholic beverages is prohibited and no illegal drugs are allowed. We need to uphold WAM's good reputation and make it a pleasant experience for all participants.
5. Each participant must have a valid fishing license and adhere to all Minnesota Fishing Regulations.
6. All participants are expected to observe check-in and check-out times.
7. Each participant is responsible for all expenses she incurs related to the trip. WAM does not make any monetary contributions to trips.
8. Participants sharing a cabin shall share clean-up duties and respect the wishes of roommates concerning noise, late hours, guests in the cabin etc. However, some compromises will be necessary.
9. There is a Trip Leader for each trip. All complaints and suggestions should be channeled to the Trip Leader.
